You must have our ^{previous} communication/circular with regard to IFWJ Presidential Election 2015.

We have to further draw your attention to the following two important matters.

1. State Returning Officers (SRO's) should be appointed to conduct the Presidential, if the need arises, but more importantly for conducting the election of National Councilors from the state. The election for the National Councilors has to be completed by 15.09.2015. This is all the all the more necessary to send the individual invitation to all National Councilors for participating in the Delegates Session.

The election of the National Councilors will be done on the basis of the 'first past post'. For example if five National Councilors are to be elected from one state and ten candidates are in the fray, then the members will be allowed to cast their votes in favour of only five candidates of their choice. In case, the elector has marked against six candidates, then his/her vote/ ballot will become void/invalid. Five top scorers will be declared elected.

It must also be made clear that one person can propose the names of as many candidates to the National Council as are to be elected from that particular state. For instance, if five National Councilors are to be elected, then a member/elector can propose the names of five candidates. Anybody, who is to contest the National Council election, cannot be the proposer for any candidate.

There will be no need for any proposer or seconder for the election of the Delegates. The number of delegates will be equivalent to that of National Councilors.



After the appointment of the SRO his/her name must be communicated to the IFWJ Headquarters <ifwj.media@gmail.com> and also Dr. Debashish Bose (CRO) on <bosemadhepura@gmail.com> and Dr. Upendra Padhi (ACRO) on <upendra.padhi@gmail.com>.

3. Every candidate for the National Council will have to deposit non-refundable Rs. 100/- and for the a Delegate Rs. 30/- as security in the IFWJ account as per details given below:
